## **INSTRUCTION SHEET**

### **1. Educational Qualification and Experience**

#### **Educational Qualification:**

BE / B. Tech (Mechanical Engineering) from reputed institute / university with minimum 60% marks and minimum Level II in NDT.

Applications not accompanied with above certificates and mark lists will not be considered and no correspondence on this will be entertained.

#### **Experience:**

Minimum 12 years of experience after graduation in planning, execution, supervision, Quality Control & Quality Assurance of Fabrication & Erection of Heavy Structural Steel Structures in Railway / Road / Metro Bridges / Piping / Oil & Gas.

Preference shall be given to candidate having experience to understand & prepare QAPs, ITPs, WPSs, Fabrication & Erection Methodology, other fabrication related procedures and knowledge of NDT / Phased Array Ultrasonic Testing (PAUT) / RT working & interpretation of its output reports

### **2. Age**

The candidates should not have crossed the upper age limit of 50 years as on 01.01.2022, as mentioned in above table.

### **3. Application Fee:**

Bank draft of Rs. 500/- in favour of FA&CAO/KRCL payable at Navi Mumbai.

Note: SC/ST candidates, minority candidates/Female candidates are exempted from payment of application fee, provided the SC/ST candidate encloses the caste certificate in Central Government format in proof thereof. In case of minority candidates affidavit in Rs.200 non-Judicial stamp paper is to be enclosed.

4. **Mode of Selection:** Only provisionally eligible candidates shall be called for selection. KRCL intends to call candidates about 10 times the number of vacancy notified for the post of Deputy Chief Engineer/ Fabrication, based on their Qualification and Experience. The selection will be by way Personal Interview.

The weightage of marks and minimum qualifying marks in each area of evaluation on a scale of 100 shall be as under:

The specific date of selection will be intimated along with the list of short listed candidates through KRCL website.

Candidates with all clear records and as per merit will be called for prescribed medical examination. The selected and medically fit candidate will be provisionally appointed based on the merit position. Candidate so selected will be on probation for a period of 2 years. Selected candidates will be required to submit Indemnity Bond and complete all recruitment formalities as prescribed. Selected candidates will be governed by all rules & regulations and service conditions as applicable to all other regular employees of KRCL.

- 5. Medical Examination:** The candidate will have to pass the prescribed medical examination as per railways standards to be conducted at the candidate's cost by Konkan Railway Corporation's Medical Authorities. The medically fit candidates will only be considered for employment in KRCL. No alternative job will be provided if a candidate selected for a particular category fails to qualify in the prescribed medical test of that category/post.
- 6. Posting :** The vacancy is for USBRL Project & Design Cell in Delhi. However, the selected candidates can be posted and transferred anywhere in the area of operation of Konkan Railway Corporation Ltd, including its project sites. The employees of Konkan Railway Corporation Ltd. are not eligible for transfer to other Zonal Railways.
- 7. Perks and Allowance:** KRCL follows CDA scale. Perks and allowance as applicable for the posts and payable to other regular employees shall be payable as per the extant rules of KRCL. The selected candidates will be eligible for all benefits as given to regular employees of KRCL in the specified pay scale.

**Pay scale:** For deserving candidates, higher pay fixation may be given within same pay scale based on number of years of experience / additional professional degree or diploma of the relevant field maximum to the 4 increments. However, decision of KRCL in this regard will be final.

- 8. Superannuation:** The age of superannuation for KRCL staff is as applicable to Central Govt. employees which is 60 years at present. The retirement benefits will be given as and if applicable on the date of superannuation.

9. **Probation:** The selected candidate will be placed on Probation for a period of Two years and the confirmation will be subject to screening of APARs grading and clearance from the Director's Committee.

10. **SERVICE AGREEMENT BOND:**

The selected candidates will be required to execute a service agreement bond to serve the organization for a minimum period of 03 years including 02 years of probation. During the probation period the corporation can terminate the service after giving one month notice or one month pay in lieu thereof without assigning any reason. On completion of probation period & confirmation, the service can be terminated by either side by giving 03 months' notice or payment in lieu thereof with or without any reason.
