





8. Other Conditions are as follows for Contractual Coaches:

- a. **Tax Deduction at Source:** The Income Tax Act or any other tax liable to be deducted as per the prevailing rules will be deducted at source before effecting the payment, for which SAI will issue TDS/Service Tax Certificate, as applicable.
- b. **Other Allowances:** No TA/DA shall be admissible for joining the assignment or on its completion. No other facilities like DA, Accommodation, Residential Phone, Conveyance/Transport, Personal Staff, Medical Reimbursement, HRA & LTC, etc., will not be admissible.
- c. **Extension:** Performance of the selected candidates would be continuously reviewed, and their extension shall be considered on the basis of periodic review/ requirement.
- d. **Leave:** Candidate will be entitled to leave at the rate of 2.5 days of each completed month with no accumulation of leave beyond a calendar year on prorata basis. Also un-availed leave in a calendar year will lapse and will not be carried forward to the next calendar year. Further, the absence up to one month may be considered without remuneration. However, in exceptional cases for professional development, training etc. this condition may be relaxed by DG, SAI. Apart from this, the female coaches may be eligible for maternity leave as per the Maternity Benefit (Amendment) Act, 2017 issued by Ministry



of Labour and Employment vide no S- 36012/03/2015-SS-I dated 12th April 2017.

- e. **TA/DA:** To undertake domestic tours subject to the approval of Competent Authority, TA/DA may be provided as per equivalent grade in Recruitment Rules of SAI.

11. PERIOD OF DEPUTATION (INCLUDING SHORT TERM CONTRACT) & CONTRACT

Deputation:

- a. The normal deputation tenure for Coach and Senior Coach is three (3) years, Chief Coach is four (4) years and High-Performance Coach is five (5) years, which can be extended up to seven (7) years (as per Recruitment Rules of SAI), depending on the requirements, or till the age of 60 years, whichever is earlier. The personnel may be repatriated pre-maturely if the performance is not found to be satisfactory.

Contract Period:

- a. **Assistant Coach:** The initial contract for Assistant Coaches shall be for a period of one (1) year and extendable in a cycle of one year subject to a maximum extension of eight (8) years subject to the annual performance

review. However, the contract can be terminated by giving a 30 days' notice period by either party i.e. SAI or the employee. In extreme cases the contract can be terminated by SAI with immediate effect without notice period and assigning of any reason. The other terms & conditions necessary for appointment in SAI will be mentioned in the detailed agreement that shall be signed by the selected candidate at the time of appointment.

- b. **Coach, Senior Coach, High-Performance Coach:** The initial contract shall be for a for period of one (1) year and extendable in a cycle of one (1) year subject to a maximum extension of eight (8) years or till age of 65 years of applicant/employee whichever is earlier, subject to the annual performance review. However, the contract can be terminated by giving a 30 days' notice period by either party i.e. SAI or the employee. In extreme cases the contract can be terminated by SAI with immediate effect without notice period and assigning of any reason. The other terms & conditions necessary for appointment in SAI will be mentioned in the detailed agreement that shall be signed by the selected candidate at the time of appointment.


12. INSTRUCTIONS ON RESERVATION (FOR CONTRACTUAL ENGAGEMENTS)

- i. Reservation will be made for candidates belonging to Scheduled Castes, Scheduled Tribes, Other Backward Classes, and the Economically Weaker Sections in respect of vacancies as may be fixed by the Sports Authority of India.
- ii. Relaxation in Age limit for SC/ST/OBC/Ex-Serviceman shall be as per DoPT OM No. 15012/2/2010- Estt(D) dated 27.03.2012.
- iii. Eligibility for Availing Reservation:
 - a. A candidate will be eligible to get the benefit of community reservation only in case the particular caste to which the candidate belongs is included in the list of reserved communities issued by the Central Government.
 - b. **The OBC candidates must produce OBC (Non-Creamy Layer) certificate based on the income for the last 03 financial years before the closing date of application.**
 - c. **A candidate will be eligible to get the benefit of the Economically Weaker Section reservation only in case the candidate meets the criteria issued by the Central Government and is in possession of requisite Income & Asset Certificate based on income for the last financial year before the closing date of application.**
 - d. Candidates seeking reservation/relaxation benefits available for SC/ST/OBC/EWS must ensure that they are entitled to such reservation/relaxation as per eligibility. They should also be in possession of all the requisite certificates in the prescribed format in support of their claim as stipulated in the Rules/Notice for such benefits by the closing date of the application.

- e. The closing date fixed for the receipt of the applications of this advertisement will be treated as the date for determining the OBC status (including that of creamy layer) of the candidates.
- iv. Candidates must ensure the community certificates that are to be produced for availing SC/ST/OBC/EWS reservation are as per standard format and proforma issued from time to time.
- v. In case Candidate will produce false/duplicate/forged caste certificate, he/she shall be liable to be dismissed from the position without any notice or assigning of any reason.


13. GENERAL TERMS AND CONDITIONS

- a. Posting: Selected candidates shall be posted at SAI Head Office, New Delhi or anywhere in any of the SAI Centres across India and the posting so made will be of purely in public interest or arising out of administrative exigencies.
- b. Confidentiality:
 - i. Selected persons will not be allowed to publish a book or a compilation of articles or participate in a radio broadcast or contribute an article or anonymously or pseudonymously in the name of any other person, if such book, article, broadcast, uses any information that he/she may gather as part of this assignment.
 - ii. During the period of engagement, Employee would be subject to the provisions of the Indian Official Secret Act, 1923 and will not divulge any information gathered by him/her during the period of his/her engagement to anyone who is not authorized to know.
 - iii. The Selected personnel at no instance can represent or give opinion or advice to others in any matter, which is adverse to the interest of the Government.
- c. In the event where the Applicant is required to proceed outstation from the place of posting on tour for official duty, he/she will be entitled to TA/DA as admissible under the rules.
- d. In case the performance of Candidate is not found satisfactory, his/her services will be discontinued after giving one-month notice.
- e. Without any prejudice to the above condition, the candidate will be terminated from his services with immediate effect without any obligations, in case the candidate is found guilty of violating any of the conditions contained in the terms of employment or is guilty of any misconduct including negligence of duties, unauthorized absence, etc.
- f. Decision of SAI in all matters regarding eligibility, selection and posting would be final and binding upon all candidates. No representation or correspondence will be entertained by SAI in this regard.
- g. SAI reserves the right to cancel the advertisement and/or the selection process at any stage without assigning any reason. Further, SAI reserves the right to modify or alter or restrict or enlarge or cancel the recruitment process, if need



so arises without issuing any further notice or assigning any reason thereafter. The decision of the SAI shall be final, and no appeal will be entertained.

- h. The DG SAI shall be the final authority in case of any dispute.
- i. The appointment of contract coaches will be purely on contract basis and does not confer any right to claim to permanent employment in SAI.
- j. SAI reserves the right to post the candidate from the selected list to any of its scheme located anywhere in India.
- k. Any litigation matters pertaining to employment at SAI shall be restricted to the jurisdiction of the Delhi courts.
- l. The candidate working in any centres of Sports Authority of India must submit an NOC from the concerned Regional Centre, failing which the application would be rejected at the initial stage.
- m. Applications received after due date are liable to be summarily rejected. Sports Authority of India will not be responsible for any delay in the submission of online application form due to any reason. No offline applications shall be entertained by Sports Authority of India.
