**Recruitment to the posts of Assistant Professor (Broad Speciality) of Government MCHs  
in the rank of Group-A, under Health & Family Welfare Department.**

Online applications are invited from the prospective candidates through proforma application to be made available on the Website of the Commission (<https://opsc.gov.in>). The link for registration /re- registration shall be available from 20.03.2024 to 20.04.2024 (Note: 20.04.2024 is the last date for submission of Registered Online Application) for recruitment to **102(One Hundred and Two)** posts of **Assistant Professor (Broad Speciality)** in 23 different disciplines of Group-A, under the Odisha Medical Education Service cadre, for posting in Government MCHs of the State of Odisha, under the Health & Family Welfare Department in the Academic Level-12 of ORSP (MCT) Rules, 2019 with usual dearness and other allowances as may be sanctioned by the Government of Odisha from time to time. The posts are purely temporary for the present and likely to be made permanent in future.

**NOTE:**

- In the event of non-availability or availability of insufficient number of eligible women candidate(s) belonging to any particular category, the remaining vacancies will be filled up by male candidate(s) of that category.
- Exchange of reservation between Scheduled Caste and Scheduled Tribe will not be considered in the event of non-availability of eligible and suitable S.C./S.T. candidates .
- The number of vacancy to be filled up on the basis of this recruitment is subject to change by Government without notice, depending upon the exigencies of public service at the discretion of the State Government.

**3. AGE:** A candidate must have attained the age of **21(twenty one)** years and must not be above the age of **45 (Forty five)** years on the **1<sup>st</sup> day of January 2024** i.e. he/she must have been born **not earlier than 2<sup>nd</sup> January 1979** and **not later than 1<sup>st</sup> January 2003**.

The upper age limit prescribed above shall be relax-able by 5 (five) years for candidates belonging to the categories of Socially & Educationally Backward Classes (S.E.B.C), Scheduled Castes (S.C.), Scheduled Tribes (S.T.), Women & Ex-Servicemen and by 10(ten) years for **Persons With Disabilities category, whose permanent disability is 40% and more.**

***Persons with Disabilities belonging to the categories of SEBC/SC/ST shall be eligible for cumulative age relaxation benefit of 15 years.***

**Provided that, the upper age limit shall be relaxed up to 5(Five) years in case of in-service Doctors serving on ad hoc basis or contractual basis under the Government or Government undertakings as the case may be.**

Provided further that, a candidate who comes under more than one category mentioned above, he/she will be eligible for only one benefit of upper age relaxation, which shall be considered most beneficial to him/her.

(SAVE AS PROVIDED ABOVE THE AGE LIMITS PRESCRIBED CAN IN NO CASE BE RELAXED).

Date of birth entered in the High School Certificate or equivalent certificate issued by the concerned Board/Council will only be accepted by the Commission.

**4. EDUCATIONAL QUALIFICATION:**

**(A)** In order to be eligible for direct recruitment, a candidate must –

- have acquired a Post Graduate Degree in the concerned Broad Speciality or any other equivalent degree or qualification prescribed by the MCI/NMC from time to time.
- Those candidates who have undergone Diplomate National Board training in concerned subject are also eligible for the post of Assistant Professor subject to fulfilling of any other criteria regarding Diplomate National Board, prescribed by MCI/NMC from time to time in force.
- The candidates who are already appointed as Assistant Professor in a Medical College without experience as SR as per previous guidelines before 08.06.2017 shall not require the one year experience as SR for applying for Assistant Professor in another Medical College.

(iv) The candidates who are already working as Asst. Professor before 08.06.2017 to undergo SR ship, they are exempted from the teaching experience requirement of one year in the concerned subject.

**NOTE:** The Diplomate of National Board (DNB) in Broad Speciality and Super Speciality qualifications when granted in a medical institution with attached hospital or in a hospital with the strength of five hundred or more beds, by the National Board of Examinations, shall be equivalent in all respects to the corresponding Broad Speciality (M.D./M.S.) and Super Speciality (D.M./M.Ch.) post graduate qualifications, but in all other cases, Senior Residency in a medical college for an additional period of one year shall be required for such qualification to be equivalent for the purposes of teaching.

##### **5. METHOD OF SELECTION:**

The selection of candidates for recruitment to the posts of Assistant Professor in Broad Speciality shall be made on the basis of **Written Test** as per the guidelines as enumerated in Odisha Medical Education Service (Method of Recruitment and Conditions of Service) Rules, 2021.

Provided that the recruitment may also be made by way of selection from amongst the Assistant Professors in any other Broad Speciality subject, having requisite qualification in the concerned Speciality subject to the condition that seniority in the Broad Speciality in the said discipline, as the case may be, shall be determined from the date of appointment in the new discipline in accordance with the placement given by the Commission, and accepted by the Government.

Provided further that in case of non-availability of MD/MS/DNB candidates in the disciplines of Anatomy, Bio-chemistry and Physiology, non-medical teachers possessing M.Sc. degree **(along with Ph.D)** i.e. M.Sc. in Medical Anatomy, Medical Bio-chemistry and Medical Physiology (as applies) along with Ph.D in Medical Anatomy, Medical Bio-chemistry and Medical Physiology (as applies) **(SECTION 3.3 and SECTION 6 TABLE 1B OF NMC TEQ 2022)** may be appointed to the extent of 15% (fifteen per cent) of the total number of posts in these disciplines (As per prevalent NMC Norms).

**Written test will be conducted in the following manner:-**

- (i) The written test shall be of **total 200 marks**.
- (ii) The total **No. of questions shall be 200** and will be of Multiple Choice Questions (**MCQ**) pattern;
- (iii) **Each** question shall carry **one mark**.
- (iv) **There shall be negative marking** for wrong answers. For each wrong answer **0.25 marks** shall be deducted from the marks awarded for correct answers.
- (v) **The qualifying marks in the written examination shall be as decided by the Commission.**
- (vi) **Duration of Examination shall be of 3 hours;**
- (vii) **Syllabus:** – (a) The syllabus for the post of Assistant Professor (Broad Speciality) shall be from Broad Speciality Subjects i.e. as per MCI approved MD/MS syllabus.  
(b) The approved syllabus for Medical M.Sc., will be as per the NMC curriculum of the Broad Speciality.

Candidates who are native or resident of Odisha shall be given preference over candidates of other States i.e. when two candidates secure equal marks in the recruitment and one of them is not a native or resident of Odisha, then out of the two, the candidate who is native or resident of Odisha shall be given preference for selection over the candidate who is not a native or resident of Odisha.

The Commission shall prepare a list of candidates in order of merit on the basis of written test, which shall be equal to the number of advertised vacancies;

Provided that, if two or more candidates secure equal marks, then the candidate securing higher marks in MBBS Examination shall find place above the others in the merit list and in case marks obtained in MBBS Examination is also the same, the candidate older in age shall be placed above the younger.

The list recommended by the Commission shall remain valid for a period of one (01) year from the date of its approval by the Government.

**Note:- Any details relating to this recruitment like cut-off marks, answer keys, individual marks etc. shall only be declared on the website of the Commission after publication of the final results and select list.**

**6. PLACE OF EXAMINATION**

The written examination for the post of Assistant Professor (Broad Speciality) will be held at Cuttack. The programme of examination shall be notified well in advance.

**7. OTHER ELIGIBILITY CONDITIONS:**

- (i) The candidate must be a citizen of India;
- (ii) The candidate must be of (a) good moral character, and (b) good mental condition and bodily health, good physique and active habits and free from organic defects or bodily infirmity so as not to create an impairment in the due discharge of duties;
- (iii) A candidate, who has more than one spouse living, will not be eligible for appointment unless the State Government has exempted his/her case from operation of this limitation for any good and sufficient reasons;
- (iv) Government servants, whether temporary or permanent, are eligible to apply provided that they possess the requisite qualification and are within the prescribed age-limit as provided under Para 3 & 4 of the Advertisement. They must inform their respective Heads of the Office in writing regarding submission of their application for this recruitment and furnish "No Objection Certificate" during document verification;
