**3. RULE OF RESERVATION:**

**A. Vertical Reservation :**

69% of the Communal reservation will be followed vertically as per the existing Government Rules / Orders i.e.,18% shall be reserved for Scheduled Castes including 3% reservation for Scheduled Caste Arunthaiyars (SCA) on

preferential basis amongst the Scheduled Castes, 1% for Scheduled Tribes, 26.5% for Backward Classes (other than Backward Class Muslims), 3.5% for the Backward Class Muslims, 20% for Most Backward Classes and Denotified Communities and 31% shall be filled by General Turns.

As per Section 27(a) of Tamil Nadu Government Servants (Conditions of Service) Act 2016, if even after filling up of the required appointments or posts reserved for Arunthathiyars amongst in Schedule V, if more number of qualified Arunthathiyars are available, such excess number of candidates of Arunthathiyars shall be entitled to compete with the other Scheduled Castes in the inter-se-merit among them and if any appointment or post reserved for Arunthathiyars remain unfilled for want of adequate number of qualified candidates, it shall be filled up by Scheduled Castes other than Arunthathiyars.

#### **B. Horizontal Reservation:**

##### **(i) Reservation for Women**

50% of the total vacancies will be reserved for women Candidates. If qualified and suitable women candidates are not available for selection against the vacancies reserved for them, those vacancies will be filled by male candidates belonging to those respective communal categories.

##### **(ii) Reservation for Persons Studied in Tamil Medium (PSTM):**

The reservation of 20% for Persons Studied in Tamil Medium shall be followed. As per Section 2(d) of the Tamil Nadu Appointment on preferential basis in the services under the State of Persons Studied in Tamil Medium Act, 2010, as amended by Act 35 of 2020 **Person studied in Tamil Medium means a person who has studied through Tamil Medium of instruction from 1<sup>st</sup> Std. and upto the educational qualification prescribed for direct recruitment in the Rules or Regulations or Orders applicable to any appointment in the services under the State.**

**[G.O.(Ms.) No.82, Human Resource Management (S) Department, Dated 16.08.2021 and G.O.(Ms.) No.01, Human Resource Management (S) Department, Dated 02.01.2024]**

- a) Candidates claiming reservation under Persons Studied in Tamil Medium (PSTM) must upload / produce evidence for the same in the form of SSLC, HSC, Course Completion Certificate, Transfer Certificate, Provisional Certificate, Degree Certificate, Mark Sheets and Certificate from the Board or University or

from the Institution, as the case may be, with evidence that he/she had studied the entire duration of the respective course(s) through Tamil Medium of instruction at the time of submission of Online application.

b) Candidates must upload the above mentioned documents as evidence for having studied in the Tamil medium from 1<sup>st</sup> Std. up to the educational qualification prescribed for appointment to the post at the time of submission of Online application.

c) If no such document as evidence for 'PSTM' is available as mentioned in para (a) above, a certificate from the Principal / Headmaster of the Educational Institution / Block Educational Officer (BEO) / District Educational Officer (DEO) / Chief Educational Officer (CEO) / District Adi Dravidar Welfare Officer / Joint Director of Technical Education / Registrar of Universities as the case may be, in the prescribed format for having studied in Tamil medium from 1<sup>st</sup> Std. upto the educational qualification prescribed for appointment to the post must be uploaded **at the time of submission of Online application.**

d) Failure to upload such documents at the time of submission of Online application as evidence shall result in the rejection of candidature after due process.

e) PSTM documents uploaded for the partial duration of any course / private appearance at any examination, at the time of submission of Online application as proof of having studied in Tamil medium, shall not be accepted and shall result in the rejection of candidature after due process.

**(iii) Reservation for Differently Abled Persons:**

The reservation of 4% Differently Abled persons shall be provided for the different categories of the Differently Abled Persons as per G.O.(Ms.) No.51, Welfare of Differently Abled Persons (DAP.3.2) Department, dated 26.12.2017.

**(iv) Reservation for Destitute Widows: (D.W.)**

As per section 26 of Tamil Nadu Government Servants (Conditions of Service) Act, 2016, 10% of vacancies set apart for women candidates in direct recruitment are reserved for Destitute Widows. If no qualified and suitable destitute widow is available, then the turn so set apart for destitute widow shall go to the women (other than DW) belonging to the respective Communal Categories.

**(v) Reservation for Ex-Servicemen:**

As per section 27 (c) of Tamil Nadu Government Servants (Conditions of Service) Act, 2016, 5% reservation will be provided for the Ex-Servicemen subject to availability of such suitable candidates. [G.O.(Ms.) No.18 Personnel and Administrative Reforms (S) Department dated.22.01.2007]. If no qualified and suitable Ex-Servicemen belonging to a particular category is available for selection for appointment against reserved turn, such turn shall be filled up by a candidate other than Ex-Servicemen but belonging to the same Communal Categories.

**(vi) Determination of the Community for Transgender:**

- a) The Transgender candidates, who do not possess any community certificate, may choose to be considered under Most Backward Classes as per G.O.(Ms.) No.28, Backward Classes, Most Backward Classes and Minorities Welfare Department, dated 06.04.2015.
- b) The Transgender candidates who belong to Scheduled Castes / Scheduled Castes (A) / Scheduled Tribes communities and possess community certificate as such, shall be considered as per their respective community.
- c) The Transgender candidates who belong to the communities other than Scheduled Castes / Scheduled Castes (A) / Scheduled Tribes and possess community certificate as such are permitted to choose to be considered as belonging to their own community or as Most Backward Classes whichever is advantageous to them, at the time of Online Registration itself. Once the option is selected, it shall be crystallized and this option shall not be changed in future.

**(vii) Reservation in Employment for Transgender:**

Reservation in Employment for Transgender shall be followed as per G.O.(Ms.) No.90, Social Welfare and Nutritious Meal Programme [SW8(2)] Department, dated 22.12.2017.

**4. QUALIFICATIONS:**

**A. Age Limit (as on 01.07.2024):**

As per the G.O (M.s) No.185, School Education (Budget-1) Department dated: 21.10.2023, the upper age limit (relating to **Age Rule 6(a)** of the Special Rules for the Tamil Nadu Elementary Educational Subordinate Service) has been fixed by the Government is as follows:

- (i) The upper age limit for the candidates belonging to General Category for appointment by direct recruitment to this selection is **53 years** of age as on the first day of July of the recruitment year viz:2024.
- (ii) Also the upper age limit for the candidates belonging to Scheduled Castes, Scheduled Tribes, Backward Class Muslims, Backward Classes, MBC/DNC and DW of all castes is **58 years** of age as on the first day of July of the recruitment year viz:2024.

**B. Educational Qualification (As on the date of Notification):**

No Candidates shall be eligible for appointment to the post of Secondary Grade Teacher, unless he / she possesses the minimum qualification as mentioned below:

- (a) Higher Secondary (or its equivalent) with at least 50% marks and 2-year Diploma in Elementary Education (by whatever name known);

(or)

Higher Secondary (or its equivalent) with at least 45% marks and 2-year Diploma in Elementary Education (by whatever name known) in accordance with the NCTE (Recognition Norms and Procedure), Regulations, 2002;

(or)

Higher Secondary (or its equivalent) with at least 50% marks and 4-year Bachelor of Elementary Education (B.El.Ed.);

(or)

Higher Secondary (or its equivalent) with at least 50% marks and 2- year Diploma in Education (Special Education);

(or)

Graduation and 2-year Diploma in Elementary Education (by whatever name known);

and

- (b) Passed in the Tamil Nadu Teacher Eligibility Test (TNTET) Paper - I

Provided that a person with Diploma in Education (Special Education) qualification shall undergo, after appointment, an NCTE recognized 6 months special programme in Elementary Education.

**As per Part III – Section 1(b) of Special Rules for the Tamil Nadu Elementary Educational Subordinate Service, Section 48-A Annexure (Referred to in Rule 6 (b) (i)) T.N. Government Gazette No.36, Date.30.01.2020 and [G.O.(Ms). No.12, School Education, EE1(1), 30.01.2020]**

The Candidates not having prescribed qualifications, as on the date of notification shall not be eligible to apply for the examination. The candidates should satisfy themselves about their eligibility criteria before applying. All qualifying certificates should have been obtained on or before the last date for submission of filled in Online application announced in the recruitment notification.

**Note:** No person shall be eligible for appointment to the posts unless he/she possesses the qualification as prescribed by the National Council for Teacher Education (NCTE) Regulations from time to time.

**C. Equivalence of Qualification:**

Candidates claiming equivalence of qualification to the prescribed qualification should upload and submit evidence for equivalence of qualification in the form of Government Order. Those who have applied for their equivalence Government Orders should submit their equivalence order at the time of Certificate Verification failing which their candidature will be summarily rejected after due process.

**D. Qualification Criteria:**

- (i) The Candidates must have obtained a Higher Secondary and 2-year Diploma in Elementary Education / Higher Secondary and 4-year Bachelor in Elementary Education (B.El.Ed.) / Higher Secondary and 2-year Diploma in Education (Special Education) / Graduation and 2-year Diploma in Elementary Education after completion of S.S.L.C., Higher Secondary Course or its equivalent (10+2+2 or 10+3+2 or 10+2+4 or 10+3+4 or 10+2+3+2 or 10+3+3+2) pattern as required under Section 25 of the Tamil Nadu Government Servants (Conditions of Service) Act, 2016), and a degree from any University or Institution, recognized by the University Grants Commission.
- (ii) Candidates who have obtained a degree after undergoing a course of one year duration (Double Degrees / Dual Degrees, additional degree etc.,) are not eligible to apply for this recruitment.
- (iii) Candidates who have obtained any two or three of the required qualifications (SSLC, HSC, U.G. Degree) simultaneously are not eligible to apply for this recruitment.

#### **E. Adequate knowledge of the official language of the State, namely, Tamil:**

- (i) No person shall be eligible for appointment to any service by direct recruitment unless he / she has adequate knowledge of the official language of the State, namely, Tamil:

Provided that a person, being otherwise qualified for appointment to the post to which recruitment is to be made, may apply for recruitment to the post, despite the fact that, at the time of such application, he / she does not possess an adequate knowledge of Tamil. If selected and appointed, such a candidate should pass the Second-Class Language Test (Full-test) in Tamil conducted by the Tamil Nadu Public Service Commission, within a period of two years from the date of appointment, failing which he / she will be discharged from service.

**As per section 21 (1) of the Tamil Nadu Government Servant (Conditions of Service) Act, 2016.**

- (ii) **Compulsory Tamil language paper for recruitment: -**

Notwithstanding anything contained in section 21, on and from the 1st day of December 2021, any person who applies for recruitment to any post in any service by direct recruitment shall pass the Tamil language paper in the examination conducted for the recruitment with not less than forty percent (40%) of total marks.

**(Tamil Nadu Government Gazette No.20, Part IV – Section 1 Dated.13.01.2023 and Section 21-A of Tamil Nadu Government Servant (Conditions of Service) Act, 2016).**

#### **5. HOW TO APPLY:**

- A. Candidates should read carefully "How to Apply" section given in the Notification / TRB's website.
- B. Candidates should apply only through Online mode in the Teachers Recruitment Boards website: <https://www.trb.tn.gov.in>. No other mode of application will be entertained. The application process is entirely Online.

**C. A Valid e-mail id and Mobile Number of candidates are mandatory for registration and e-mail id should be kept active for all future correspondence.**

D. Evidence for claims made by the candidate, while applying in Online Mode shall be uploaded by the candidate. The same will be verified subsequently at the time of Certificate Verification, if called for.

E. All the particulars and documents mentioned in the Online application including name of the candidate, post applied for, communal reservation, date of birth, address and all other fields will be considered as final. The Candidates can make any changes (addition / deletion) if necessary, while filling the Online application before final submission. **No modifications will be allowed after the final submission of Online application.** Since certain fields are mandatory and fixed which cannot be edited, candidates are requested to fill in the Online application form with utmost care and caution, **as no correspondence regarding change of those particulars will be entertained at any cost.**

F. Incomplete or defective applications shall be summarily rejected. No representation or correspondence regarding such rejection shall be entertained under any circumstances.

G. The candidates are advised to exercise due diligence at the time of filling the application. In case, if duplicate application of a candidate for the same subject is detected, the Board will consider only the latest application, if it is in order.

If the required certificates are not uploaded by the candidate while applying his / her application will be rejected after due process.

(If not available, candidate should upload mark sheets of all semester)
  - b). Degree Certificate or Provisional Certificate
- (vi) Teacher Eligibility Test Certificate – Paper I

### **B. Community Certificate:**

Community Certificate should be obtained from the following authorities of Government of Tamil Nadu by the candidate claiming Communal reservation as the case may be.

- (i) ST - Revenue Divisional Officer (if the certificate is issued after 11.11.1989)
- (ii) SC/SCA – Tahsildar of native taluk of the candidate.
- (iii) BC / MBC / DNC – Headquarters Deputy Tahsildar or Special Deputy Tahsildar.
- (iv) Community Certificate of Married woman candidate issued with Father's name alone shall be accepted.
- (v) If the Community Certificate is issued with Husband's name, the woman candidate will be considered under General Turn (G.T) only.
- (vi) Community Certificates issued by any other State or Union Territory Authorities will not be considered against vacancies reserved for 69% communal reservation. They will be considered under General Turn (G.T.) only.

**C. Persons Studied in Tamil Medium (PSTM) Certificate:**

For the post of Secondary Grade Teachers, candidate who claims reservation under Persons Studied in Tamil Medium (PSTM) category has to upload Tamil Medium Study Certificate in the prescribed format.

**(ANNEXURE I, II & III). as per G.O.(Ms.) No.82, Human Resource Management (S) Department, Dated 16.08.2021 and G.O.(Ms.) No.01, Human Resource Management (S) Department, Dated 02.01.2024.**

**D. Disability Certificate:**

Candidates who claim the reservation under Differently Abled category, has to upload an Identity Card and Passbook with Disability Certificate issued by the Competent Authority.

**E. Destitute Widow (DW) Certificate:**

Candidates who claim the reservation under Destitute Widow has to upload a certificate issued by the Revenue Divisional Officer or the Assistant Collector or the Sub Collector concerned.

**F. Ex-Servicemen Certificate:**

Candidates who claim the reservation under Ex-Servicemen reservation has to upload documentary Evidence such as Discharge book / Other proof of Service.

**G. No Objection Certificate (N.O.C.):**

Candidates who are in the service of the Indian Union or a State in India or in the employment of Local Bodies or Universities, or Quasi Government Organizations constituted under the authority of the Government of India or of a State in India whether in regular service or in a temporary service need not send their application through their Head of Department or Employer. Instead, they may directly apply to the Teachers Recruitment Board after duly informing their Employer in writing that they are applying for the particular recruitment and with the condition that they should produce “No Objection Certificate” in the form prescribed as in Annexure III, from the Head of the Department or the Appointing Authority at the time of

attending the Certificate Verification, if called for.

**Note :**

- (i) Candidates who get employment after the submission of their applications and before the receipt of intimation admitting them to the Certificate Verification / requiring them to produce original documents for verification should also produce the “No Objection Certificate”.
- (ii) In case any Criminal / Disciplinary action is taken against any Candidates or if any punishment is imposed against such Candidates after the production of “No Objection Certificate” (NOC) and before the actual appointment, such candidates should report this fact forthwith to the Teachers Recruitment Board indicating their Register Number. Any violation or failure to comply with these instructions will end in rejection of candidature.

**H. Conduct Certificate from the Last Studied Institution:**

Conduct Certificate is to be obtained from the Head of Institution in which he/she last studied and uploaded. In case the candidate has studied the course through Correspondence, this fact should be stated along with necessary evidence. **7. EXAMINATION FEE :**

For SC, SCA, ST and differently abled persons the examination fee is Rs. 300/- Since the examination fee is different for various categories, candidates are advised to enter the correct Community / Category of Disability. Once the payment is made, it will not be refunded.

- B. SMS alert regarding successful payment of examination fee will be sent to the registered mobile number of the candidate.
- C. Online payment to be made only through Payment Gateway. (Net banking / Credit Card / Debit Card)
- D. Offline mode of payment in any form such as Demand Draft / Postal order, etc. will not be accepted.
- E. The candidates should also have to pay the service charges as applicable for Online payment.
- F. Failure to pay the prescribed fee in time, along with the Online application, will result in the rejection of application after due process.
- G. Fee once remitted shall not be refunded or adjusted for future examination under any circumstances.
- H. If a candidate pays the fee for more than one time, the amount will not be refunded.

- (ii) The participation of the Candidates in the OMR based Written Examination is purely provisional and does not confer any right for selection. acceptance of their claim in the application.

### **(iv) Examination Results:**

## **11. ACTION AGAINST CANDIDATES FOUND GUILTY OF MISCONDUCT:**
