#### General information and conditions: -

#### 1. <u>Benefits under Council service:</u>

- a. These posts carry usual allowances i.e. Dearness Allowance (DA), House Rent Allowance (HRA), Transport Allowance (TA) etc. as admissible to the central government employees and as made applicable to CSIR. Council employees are also eligible for accommodation of their entitled type as per CSIR allotment rules depending on availability in which case HRA will not be admissible.
- b. All new entrants will be governed by the "National Pension System" based on defined contributions for new entrants recruited in Central Government Services on or after 01.01.2004, as adopted by CSIR for its employees. However, persons selected from other Government Departments/ Autonomous Bodies/Public Sector Undertakings/ Central Universities having pension Scheme on Govt. of India pattern will continue to be governed by the existing Pension Scheme i.e., CCS (Pension) Rules, 2021. Provided they were in Govt. Service prior to 01.01.2004 and are covered by CCS (Pension) Rules, 2021.
- c. In addition to the emoluments indicated against each category of posts, benefits such as applicability of New Pension System, reimbursements of Medical Expenses, Leave Travel Concession and House Building Advance are available as per CSIR rules.
- d. CSIR provides excellent opportunities to deserving candidates for career advancement under Assessment Promotion scheme for Assistants/Technician.
- e. Deserving candidates may be considered for advance increment as per CSIR Rules.

#### 2. Other conditions

- a. The applicant must be a citizen of India.
- b. All applicants must fulfill the essential requirements for the post and other conditions stipulated in the advertisement as on the last date of submission of online Application i.e. <u>31.03.2024 up to 5:30 PM</u>. Applicants are advised to satisfy themselves before applying that they possess at least the essential qualifications laid down for various posts as on the last date of submission of online applications i.e. <u>31.03.2024 up to 5:30 PM</u>. No enquiry for advice as to eligibility will be entertained.
- c. Only online mode of application is invited. No other means of application will be entertained.
- d. Mere passion of the prescribed essential qualifications are does not entitle candidates for the Post.
- e. The prescribed qualifications should have been obtained through recognized Universities/Institutions etc.
- f. Incomplete applications are liable to be rejected.
- g. In respect of equivalent clause in Essential Qualifications, if a candidate is claiming a particular qualification as equivalent qualification as per the requirement of advertisement, then the candidate is required to produce the extant relevant order/letter in this regard, indicating the Authority (with number and date) under which it has been so treated otherwise the Application is liable to be rejected.
- h. The period of experience rendered by a candidate on part time basis, daily wages, visiting/ guest faculty will not be counted while calculating the valid experience for short listing the candidates for Trade/Written Test.
- i. If any document/ certificate furnished is in a language other than Hindi or English, a transcript of the same duly attested by a Gazetted officer or notary is to be uploaded.
- j. The date for determining the upper age limit, qualifications and /or experience shall be the closing date prescribed for submission of online application i.e. **31.03.2024**
- k. The period of experience if any, in a discipline / area of work, wherever prescribed, shall be counted only after the date of acquiring the minimum essential educational qualifications prescribed for that Post.
- I. Persons with disabilities (PwBD) fulfilling the eligibility conditions prescribed under GOI instructions are encouraged to apply.
- m. Any discrepancy found between the information given in application and as evident in original documents will make the candidate ineligible for appearing in Trade/Written Test.
- n. The selected candidates will be on probation for a period of ONE YEAR from the date of joining of the post in the Laboratory. The probationary period may be extended or curtailed at the discretion of the Competent Authority.
- o. The decision of the IITR/CSIR in all matters relating to eligibility, acceptance or rejection of applications, mode of selection, conduct of examination/Trade/Written Test will be final and binding on the candidates.
- p. Canvassing in any form and / or bringing any influence political or otherwise will be treated as a disqualification for the post.
- q. Syllabus will be notified on Institute's website.
- r. Examination venue for Trade Test/Written exam will be in Lucknow.
- s. Facility to download Admit Card will be available on Institute's website only.
- t. The number of advertised posts are tentative, the actual number of posts may increase or decrease depending upon the requirement of the Institute.
- u. For any Technical issue relating for filling online application and for any Administrative issue, candidates may inform at <u>so.recruit@iitr.res.in</u>
- v. Wherever two or more candidates have secured equal aggregated marks, the tie may resolved in accordance with the order of precedence given below (ascending order), till tie is resolved :
  - i) Candidate with higher marks in the papers of concerned subject place higher.
  - ii) Candidates with lesser negative marks, if applicable, in the papers of concerned subject of written test place higher.
  - iii) Candidates with lesser negative marks, if applicable in the papers (which have been considered for preparation of merit) of Written Test placed higher.
  - iv) Date of Birth, with older candidate placed higher.
  - v) Candidates acquiring Essential Degree earlier place higher.
  - vi) Alphabetical order in which first names of the candidates appear.

# 3. <u>Relaxations :</u>

- a. The minimum age of the candidate should not be below 18 years and should not be above the prescribed upper age limit as on last date of submission of the online application. The upper age limit is relaxable up to 05 years for SC/ST and 03 years for OBC as per Government orders in force only in those cases where the post is reserved for respective categories, on production of relevant certificate in the prescribed format signed by the specified authority at the time of Trade/Written Test.
- b. Upper age limit is also relaxable up to five years for the regular employees working in CSIR laboratories / institutes, Government Departments, autonomous bodies and public sector undertakings.
- c. **For Technician Post only:**-As per GOI provisions, age relaxation for Widows, Divorced Women and Women Judicially separated from Husbands, the upper age limit is relaxable up to the age of 35 years (up to 40 years for members of Scheduled Castes/Scheduled Tribes in respect of the posts reserved for them) for Widows, divorced Women and Women Judicially separated from their Husbands who are not remarried. The persons claiming age relaxation under this sub-para would be required to produce following documentary evidence:
  - i) In case of Widow, Death Certificate of her husband together with the Affidavit that she has not remarried since.
  - ii) In case of divorced Women and Women judicially separated from their husbands, a certified copy of the judgment/decree of the appropriate Court to prove the fact of divorce or the judicial separation, as the case may be, with an Affidavit in respect of divorced Women and they have not remarried since.
- d. Age relaxation to Persons with Benchmark Disabilities(PwBD): Age relaxation of 10 years is allowed (total 15 years for SCs/STs and 13 years for OBCs in respect of the posts reserved for them) to Hearing Handicapped (HH), Visually Handicapped (VH), Orthopedically Handicapped (OH) and others (Autism, intellectual disability, specific learning disability and mental illness) persons. The persons claiming age relaxation under this sub-para would be required to produce a certificate in prescribed proforma in support of their claims clearly indicating that the degree of physical disability is 40% or more. In any case, the appointment of these candidates will be subject to their being found medically fit in accordance with the standards of medical fitness as prescribed by the Government for each individual for the posts to be filled by Direct Recruitment.
- e. Any other Age relaxation shall be applicable as per extant Gol/ CSIR Recruitment Rules.

# 4: How to apply

- a. Candidates can apply through online portal, link of which will be available on CSIR-IITR website <u>https://www.iitr.res.in</u> from 01.03.2024 at 10:00 AM to 31.03.2024 till 5:30 PM. and last date of submitting the completed application on portal is <u>31.03.2024 till 5:30 PM</u>.
- b. It is mandatory to take the print out of the successfully submitted online application form& payment receipt (if any), sign the same and attach the self attested mandatory documents &photograph and keep it for submission as and when asked for. Only self-attested required documents should be uploaded in online application form.
- **c.** Candidates are required to pay application fee of Rs.500./- as per 'Fee Payment Procedure' available on the website.
- **d.** The candidates belonging to SC/ST/PwBD/Women/Regular CSIR Employees/Ex-servicemen are exempted from payment of application fee.
- e. Candidate is required to upload his/her recent passport size scanned colour photograph, signature each (max size 50 KB) and also relevant certificates at the specified places in the online application.
- f. Fee once paid will not be refunded on any account nor can it be held in reserve for any other recruitment of selection process.
- **g.** A candidate can apply for multiple post codes subject to fulfilling all eligibility conditions attached to each individual post code. However, candidate needs to fill the separate application for each post code with the requisite application fee.
- i. Candidates are advised to keep the application form generated after online submission, with themselves along with all copies of the requisite certificates, mark sheets, age proof, education qualifications, experience, re-prints of publications and caste certificate, if applicable, and produced the same whenever asked by the CSIR-IITR to do so.

- **k.** Incomplete applications (i.e., without photograph, unsigned and applicable testimonials etc.) will not be entertained and will be summarily rejected.
