HEALTH

The candidate should have sound health. Before joining, candidates will have to undergo medical examination at any of the specified govt. hospitals and the decision will be final and binding. No relaxation in health standards is allowed.

GENERAL CONDITIONS:

- Only Indian Nationals are eligible to apply.
- All qualifications should be from Universities / Institutions recognized and approved in India.
- All computations of age/ experience requirement / qualification shall be done w.r.t. the last date of receipt of online application as mentioned in the advertisement.
- Candidates claiming to belong to any particular category shall necessarily have a valid EWS/OBC/SC/ST/Disability certificate, as the case may be, from the Competent Authority. Where there is vacancy identified for such category, upper age limit is relaxed by 5 years for SC/ST candidates, by 3 years for OBC candidates, by 10 years for PwBD candidates. 5 years age relaxation for candidates who had ordinarily been domiciled in the State of Jammu & Kashmir during the period 01.01.80 to 31.12.89. Relaxation of age to Ex-Serviceman as per Govt. guidelines. Candidates working in Government organisations/PSUs are required to submit NOC at the time of interview. For SC/ST/PwBD category, the minimum marks in qualifying degree is 50%.
- Selection will be made by two stage shortlisting i.e online written test to be held in Delhi/Noida. Shortlisted candidates will be called for personal interview. Management reserves the right to raise the minimum eligibility standards/ criteria as per requirement.
- Depending on the requirement, the Company reserves the right to cancel / restrict / curtail / enlarge the number of vacancies, if need so arises, without any further notice and without assigning any reason thereof.
